Divorce Mediation Clinic

In an ongoing partnership between the Bar Association's Pro Bono programs and Roger Williams University School of Law's Mediation Clinic, a family law mediation clinic was held this past November, successfully providing pro bono aid to many low income couples who had nowhere else to turn for legal assistance. All couples that participated were then placed with a volunteer attorney to complete the court process.
