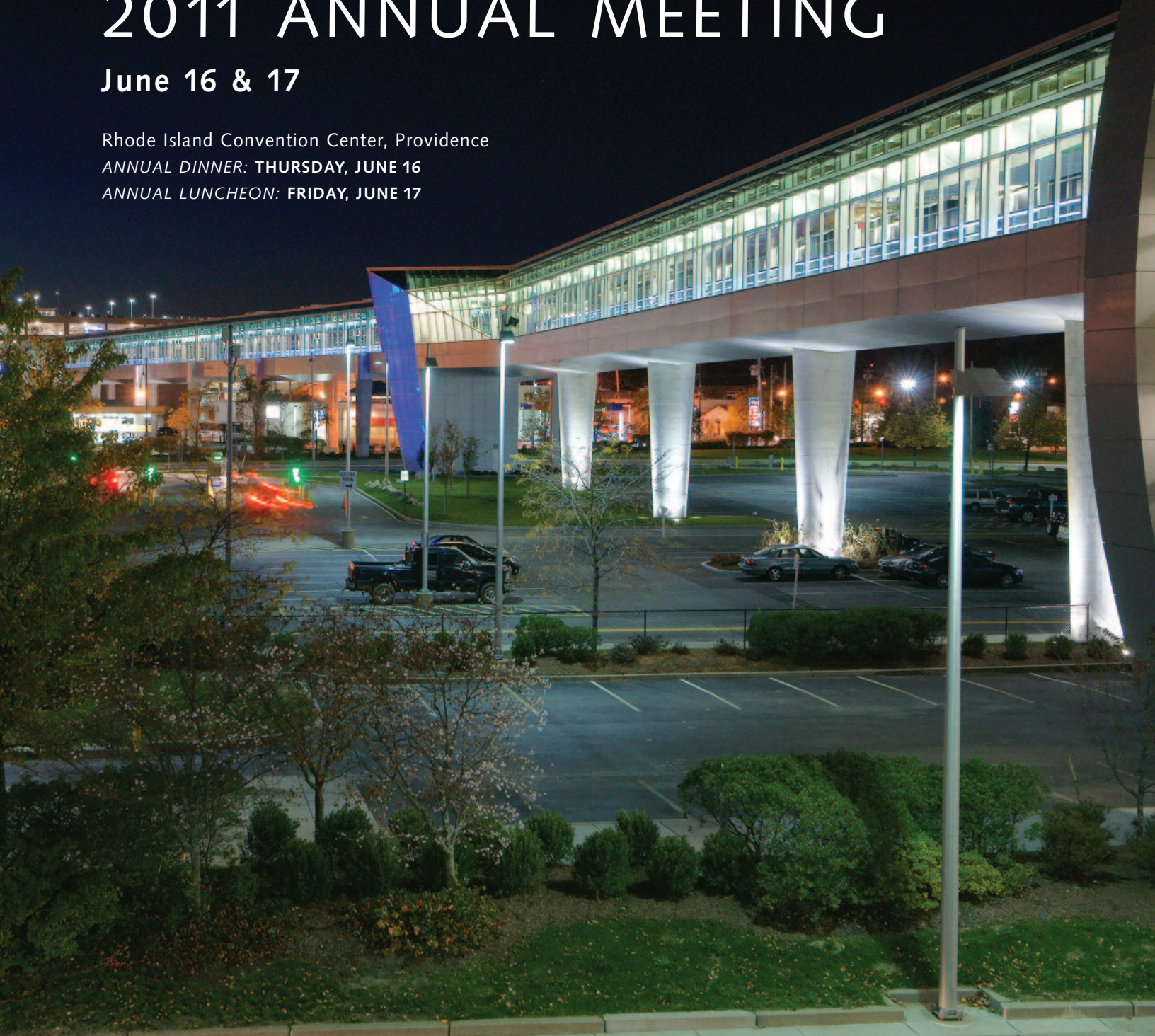

MORRIS SELIGMAN DEES, JR., ESQ., and his Montgomery, Alabama law partner Joseph J. Levin, Jr. and civil rights activist Julian Bond founded the Southern Poverty Law Center, a non-profit organization dedicated to seeking justice. Through the Southern Poverty Law Center, Dees uses the law like a sword in his battle against prejudice and hatred. In the 1980s and '90s, he bankrupted the Ku Klux Klan and neo-Nazi groups with a series of historic lawsuits. Today, he focuses his attention on anti-government militias. In his book, *Gathering Storm: America's Militia Threat*, Dees explains the dangers these groups represent. He is also author of *A Lawyer's Journey*, an autobiography, and *Hate on Trial: The Case Against America's Most Dangerous Neo-Nazi*.

Peter Kramer, M.D.

Brown Medical School Professor, practicing psychiatrist and best-selling author of six books including *Listening to Prozac* and *Against Depression*, Dr. Kramer persuasively argues that depression is a woefully undertreated, serious disease with significant consequences, not only for the individual, but society. He addresses the impact and management of this life-threatening illness, and examines how depression can impair the practice and a practitioner's quality of life.
